The Connecticut Roofing Contractors Association's George Ordway Scholarship is open to students seeking post-secondary careers. Applicants must be the children of owners and/or employees of CRCA member companies. The scholarship is open to entering freshman and undergraduate students. The scholarship will be in an amount determined annually by the Connecticut Roofing Contractors Association Scholarship Committee.

Selection will be based on academic goals as stated by the applicant, academic achievement, and involvement in extra-curricular and community activities. All applications must be accompanied by an academic transcript from the educational institute in which the candidate is currently enrolled. If the candidate is entering a different educational institution as of September of the current year, a letter of acceptance to that institution must accompany the application.

Applicants must have demonstrated leadership potential and be of good character. Financial need is not a primary factor.
